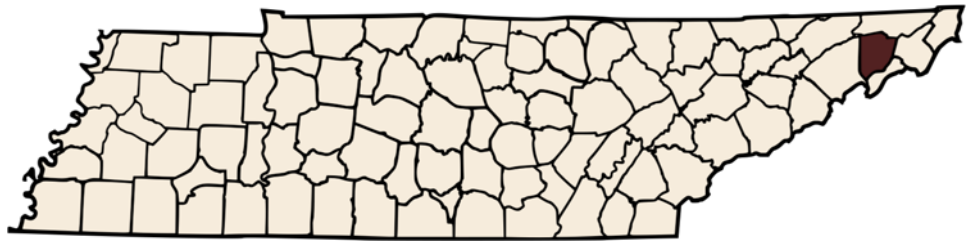




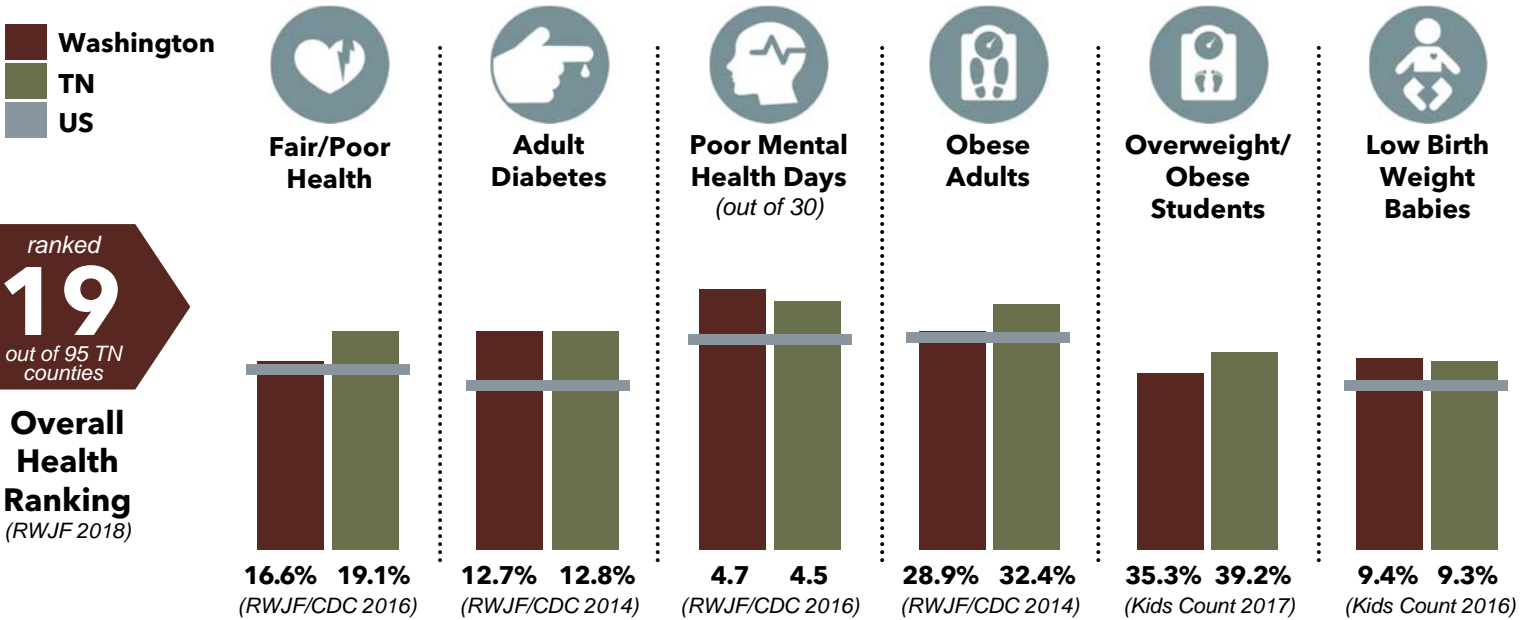

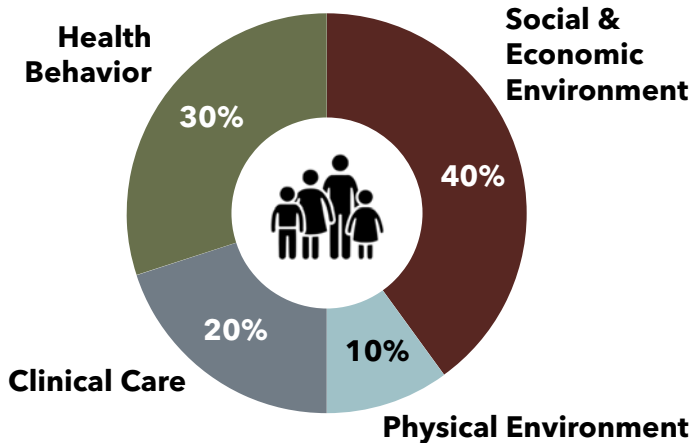

Our behaviors, physical, social, and economic environments, and access to clinical care are all major drivers of health.

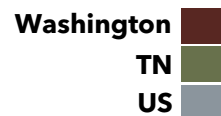


The factors that drive our health are complex and interconnected. They can affect each other while also influencing our health and well-being.

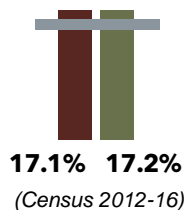

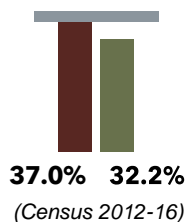

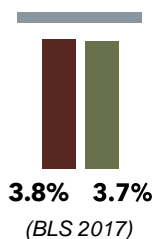
Poverty Rate

Crime Rate (per 1K pop.) (TBI 2017)



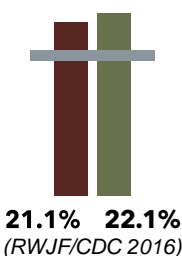

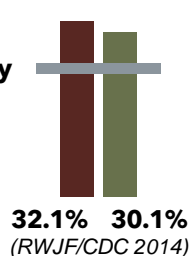
Drug Overdose Deaths (per 100K pop.) (CDC 2012-16)

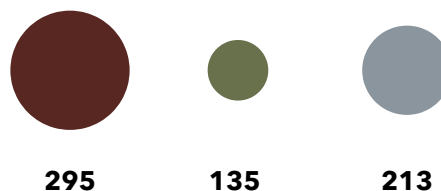
Uninsured Rate, Age <65 (Census 2016)



Pregnant Women Receiving Adequate Prenatal Care (Kids Count 2016)



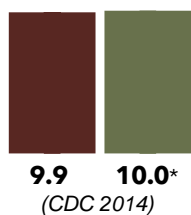
Mental Health Providers (per 100K pop.) (RWJF/CMS 2017)



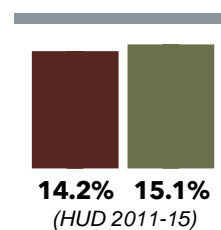

Due to data availability, only 72 counties are ranked for overdose deaths and 87 counties for mental health providers.
